Doering seconds to grant authority to the Auction Committee, consisting of Bill Buhrmaster, Ken Burbach, Pete Deets, Jeff Huttenburg, Bob Ristow, Rick Thiele, and Bobbie Wagner to hold an auction on, or just prior to, May 2<sup>nd</sup> 2015 for the purpose of disposing unusable and unneeded items, and further to retain Bill Perkins located at Avalon, WI, and Travis Hamele located at Portage, WI both with United Country Realty and Auction as auctioneers for this function, and further to grant authority to the Auction Committee to make all decisions regarding the selection of items to be auctioned, with the stipulation that only rolling stock that has been de-accessed and all other items deemed to be unusable or unneeded for Mid-Continent be selected, and further to suspend the requirements for de-accession in the Collection Policy for this auction only, and further to suspend all current scrapping policies for this event only.
